BENZYL C8-18 ALKYLDIMETHYLAMMONIUM CHLORIDE	<p>Asthma-like symptoms may continue for months or even years after exposure to the material ceases. This may be due to a non-allergenic condition known as reactive airways dysfunction syndrome (RADS) which can occur following exposure to high levels of highly irritating compound. Key criteria for the diagnosis of RADS include the absence of preceding respiratory disease, in a non-atopic individual, with abrupt onset of persistent asthma-like symptoms within minutes to hours of a documented exposure to the irritant. A reversible airflow pattern, on spirometry, with the presence of moderate to severe bronchial hyperreactivity on methacholine challenge testing and the lack of minimal lymphocytic inflammation, without eosinophilia, have also been included in the criteria for diagnosis of RADS. RADS (or asthma) following an irritating inhalation is an infrequent disorder with rates related to the concentration of and duration of exposure to the irritating substance. Industrial bronchitis, on the other hand, is a disorder that occurs as result of exposure due to high concentrations of irritating substance (often particulate in nature) and is completely reversible after exposure ceases. The disorder is characterised by dyspnea, cough and mucus production.</p> <p>General depressed activity, impaired liver function tests, increased urine volume, changes in bone marrow, chronic pulmonary oedema, gastrointestinal changes recorded. [The surfactant contained in this product is readily biodegradable, but is regarded as toxic to aquatic organisms. OECD 302B testing of the quaternary ammonium compound contained in this product indicates that it is readily biodegraded, but it is also regarded as toxic to aquatic organisms. Therefore, the undiluted product should be prevented from entering waterways. If possible, the expended material should be drained to the sewer as sewerage treatment will greatly reduce damage to water quality. Whilst the aquatic toxicity of the components is relatively high (96 hour maximum safe concentration in the order of 1-5 mg/L), dilution of the product with the large excesses of water present and the relatively rapid biodegradation of the surfactants and quaternary ammonium compound should ensure minimal ecotoxicity.
